

PRIVACY ACT AUTHORITY – Business



In this Authority reference to:

"I", "My", and "Me" refers to each of the persons who has signed this Application for Finance (named below) as:

- a. A partner, director, non-independent trustee or in any other capacity of an Organisation Applicant; or
- b. An individual Guarantor.

"Other Entity" includes any bank, financial institution, credit reporter, government department (e.g. the Ministry of Justice) or government agency (e.g. the NZ Transport Agency), insurance company, employer, or any other person or entity.

1. **I agree** this Authority relates to personal information ("Personal Information") about Me which I or any Other Entity provides to The Money Company Limited and/or The Money Company Hawke's Bay Limited (together and severally "You") and My motor vehicle trader if applicable ("dealer").
2. My Personal Information may be used:
 - a. To assess My credit worthiness for the purposes connected with the Applicant and in considering this Application;
 - b. To verify My identity as may be required by the Anti-Money Laundering and Countering Financing of Terrorism Act 2009 and regulations;
 - c. For the management, assessment, protection, enforcement by You of any agreement with Me and any security interest granted by Me in Your favour, including insurance details in relation to any property secured in Your favour;
 - d. Reporting My credit defaults and my payment history;
 - e. For promotional and marketing purposes;
 - f. For fines enforcement purposes and for obtaining the balance of fines in default; and
 - g. Any other related purpose.
3. **I authorise** You and the dealer and (in relation to paragraph d. below only) any motor vehicle supplier and any of Your related companies to:
 - a. Exchange Personal Information about Me;
 - b. Make enquiries, disclose and obtain any Personal Information about Me to and from any Other Entity for the purposes listed in paragraph 2 above (except 2e.) and I also authorise the provision of such Personal Information by any Other Entity to You and/or the dealer;
 - c. Disclose My Personal Information to any motor vehicle supplier and any of Your related companies, for promotional and marketing purposes and to any other entity with whom You or the dealer wish to do joint marketing programmes with;
 - d. Send Me/Us promotional marketing information.
4. **I understand** that all information You provide to any credit reporter (such as Veda Advantage) including information relating to any default by Me of any obligation to You will be held by the credit reporter for its credit reporting service and the credit reporter may give such information to its customers who use its service.
5. **I understand** that if I (or any other person who is required by You to provide a Privacy Act Authority) do not provide You with a Privacy Act Authority, You might decline any application for finance or finance lease to which the Privacy Act Authority relates.
6. **I understand** that I may access the Personal Information held by You and the dealer and ask that the Personal Information be corrected in accordance with the provisions of the Privacy Act 1993.
